Active Member: \$75/year An active member shall be a person in good standing, who earns the major portion of his/her livelihood as a professional photographer, or who is the owner or manager of a professional photography business, or an official representative of such a business, or who is an independent color artist or negative retoucher. Only active members shall have the right to vote and hold elective office in this association. Active members are eligible for scholarships awarded by this organization.

Sustaining Member: \$65/year A sustaining member shall be a person or firm who manufactures or distributes photographic equipment, materials, or merchandise, or who offers a service to professional photographers, or the official representative of such firms. Sustaining members shall be entitled to all the privileges of membership except voting and holding elective office in this organization and scholarship awards.

Associate Member: \$55/year An associate member shall be a person who is an employee of either an active or sustaining member or someone interested in professional photography but not actively involved in the profession. Associate members shall be entitled to all the privileges of membership except voting, holding elective office in this organization and scholarship awards.

Life Member: No Dues A life member shall be a person who has retired from the photography profession and who has been a member of the IPPA for at least 20 years. Life membership may be awarded upon the approval of and at the discretion of the Board of Directors. Life members are entitled to all the privileges of active members. Life members will not be required to pay dues or convention fees. Life members shall pay meal fees where applicable.
